NOTES The purpose of this document is to: Draw special attention to certain general conditions (i) applicable to NWPB's bids, contracts and orders; and (ii) To ensure that clients be familiar with regard to the rights and obligations of all parties involved in doing with NWPB In this document words in the singular also mean in the plural and vice versa and words in the masculine also mean in the feminine and neuter. • The General Conditions of Contract will form part of all bid documents and may not be amended • Special Conditions of Contract (SCC) relevant to a specific bid, should be compiled separately for every bid (if applicable) and will supplement the General Conditions of Contract. Whenever there is a conflict, the provisions in the SCC shall prevail.

General Conditions of Contract

1. Definitions

The following terms shall be interpreted as indicated:

- 1.1 "Closing time" means the date and hour specified in the bidding documents for the receipt of bids;
- 1.2 "Contract" means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein;
- 1.3 "Contract price" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations;
- 1.4 "Corrupt practice" means the offering, giving, receiving or soliciting of anything of value to influence the action of a public official in the procurement process or in contract execution;
- 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidised by its Government and encouraged to market its products internationally;
- 1.6 "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly or components, a commercially recognised new product results that is substantially different in basic characteristics or in purpose or utility from its components;
- 1.7 "Day" means calendar day;
- 1.8 "Delivery" means delivery in compliance of the conditions of the contract or order;
- 1.9 "Delivery ex stock" means immediate delivery directly from stock actually on hand;
- 1.10"Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specific site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained;
- 1.11"Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA;
- 1.12"Force Majeure" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes;
- 1.13"Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition;
- 1.14"GCC" means General Conditions of Contract;
- 1.15"Goods" means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract;
- 1.16"Imported content" means that portion of the bidding price represented by the cost of components, parts or materials which have been or are still to be imported (whether by the supplier or his subcontractors) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs such as landing

costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handing charges to the factory in the Republic where the supplies covered by the bid will be manufactured;

- 1.17"Local content" means that portion of the bidding price which is not included in the imported content provided that local manufacture does take place;
- 1.18"Manufacture" means the production of products in a factory using labour, materials, components and machinery and includes other related value adding activities;
- 1.19"Order" means an official written order issued for the supply of goods or works or the rendering of the service;
- 1.20"Project Site" where applicable, means the place indicated in the bidding documents;
- 1.21"Purchaser" means the organisation purchasing the goods;
- 1.22"Republic" means the Republic of South Africa;
- 1.23"SCC" means the Special Conditions of Contract;
- 1.24"Services" means those functional services ancillary to the supply of the goods, such as transportation and any other incidental services, such as installation, commissioning, provision of technical assistance, training, catering, gardening, security, maintenance and other such obligations of the supplier covered under this contract;
- 1.25"Written" or "in writing" means handwritten in black ink or any form of electronic or mechanical writing

2. Application

- 2.1 These general conditions are applicable to all bids, contracts and orders including bids for functional and professional services, sales, hiring, letting and the granting or acquiring of rights, but excluding immovable property, unless otherwise indicated in the bidding documents;
- 2.2 Where applicable, special conditions of contract are laid down to cover specific supplies, services or works;
- 2.3 Where such special conditions of contract are in conflict with these general conditions, the special conditions shall apply.

3. General

3.1 Unless otherwise indicated in the bidding documents, the purchaser shall not be liable for any expense incurred in the preparation and submission of a bid. Where applicable a non-refundable fee for documents may be charged

4. Standards

4.1 The goods supplied shall conform to the standards mentioned in the bidding documents and specifications

5. Use of contract documents and information inspection

- 5.1 The supplier shall not, without the purchaser's prior written consent, disclose the contract, or any provision thereof, or any specification, plan, drawing, pattern, sample, or information furnished by or behalf of the purchaser in connection therewith, to any person other than a person employed by the supplier in the performance of the contract. Disclosure to any such employed person shall be made in confidence and shall extend only so far as may be necessary for purposes of such performance;
- 5.2 The supplier shall not, without the purchaser's prior written consent, make use of any document or information mentioned in GCC clause 5.1 except for purposes of performing the contract;

- 5.3 of the purchaser and shall be returned (all copies) to the purchaser on completion of the supplier's performance under the contract if so required by the purchaser;
- 5.4 The supplier shall permit the purchaser to inspect the supplier's records relating to the performance of the supplier and to have them audited by auditors appointed by the purchaser, if so required by the purchaser.

6. Patent Rights

6.1 The supplier shall indemnify the purchaser against all third party claims of infringement of patent, trademark, or industrial design rights arising from use of the goods or any part thereof by the purchaser.

7. Performance Security

- 7.1 Within thirty (30) days of receipt of the notification of contract award, the successful bidder shall furnish to the purchaser the performance security of the amount specified in the SCC;
- 7.2 The proceeds of the performance security shall be payable to the purchaser as compensation for any loss resulting from the supplier's failure to complete his obligations under the contract;
- 7.3 The performance security shall be denominated in the currency of the contract, or in a freely convertible currency acceptable to the purchaser and shall be in one of the following forms:
 - (a) a bank guarantee or an irrevocable letter of credit issued by a reputable bank located in the purchaser's country or abroad, acceptable to the purchaser, in the form provided in the bidding documents or another form acceptable to the purchaser; or
 - (b) a cashier's or certified cheque
- 7.4 The performance security will be discharged by the purchaser and returned to the supplier not later than thirty (30) days following the date of completion of the supplier's performance obligations under the contract, including any warranty obligations, unless otherwise specific in the SCC.

8. Inspections, tests and analyses

8.1 All pre-bidding testing will be for the account of the bidder;

8.2 If it is a bid condition that supplies to be produced or services to be rendered should at any stage during production or execution or on completion be subject to inspection, the premises of the bidder or contractor shall be open, at all reasonable hours, for inspection by a representative of NWPB or an organisation acting on behalf of NWPB;

- 8.3 If there are no inspection requirements indicated in the bidding documents and no mention is made in the contract, but during the contract period it is decided that inspections shall be carried out, the purchaser shall itself make the necessary arrangements, including payment arrangements with the testing authority concerned;
- 8.4 If the inspections, tests and analyses referred to in clauses 8.2 and 8.3 show the supplies to be in accordance with the contract requirements, the costs of the inspections, tests and analyses shall be defrayed by the purchaser;
- 8.5 Where the supplies or services referred to in clauses 8.2 and 8.3 do not comply with the contract requirements, irrespective of whether such supplies or services are accepted or not, the cost in connection with these inspections, tests or analyses shall be defrayed by the supplier;
- 8.6 Supplies and services which are referred to in clauses 8.2 and 8.3 and which do not comply with the contract requirements may be rejected;
- 8.7 Any contract supplies may on or after delivery be inspected, tested or analyzed and may be rejected if found not to comply with the requirements of the contract. Such rejected supplies shall be held at the cost and risk of the supplier who shall, when called upon, remove them immediately at his own cost and forthwith

substitute them with supplies which do comply with the requirements of the contract. Failing such removal the rejected supplies shall be returned at the supplier's costs and risk. Should the supplier fail to provide the substitute supplies forthwith, the purchaser may, without giving the supplier further opportunity to substitute the rejected supplies, purchase such supplies as may be necessary at the expense of the supplier;

8.8 The provisions of clauses 8.4 to 8.7 shall not prejudice the right of the purchaser to cancel the contract on the account of a breach of the conditions thereof, or to act in terms of clause 23 of the GCC.

9. Packing

- 9.1 The supplier shall provide such packing of the goods as is required to prevent their damage or deterioration during transit to their final destination, as indicated in the contract. The packing shall be sufficient to withstand, without limitation, rough handling during transit and exposure to extreme temperatures, salt and precipitation during transit, and open storage. Packing, case size and weights shall take into consideration, where appropriate, the remoteness of the goods' final destination and the absence of heavy handling facilities at all points in transit;
- 9.2 The packing, marking and documentation within and outside the packages shall comply strictly with such special requirements as shall be expressly provided for in the contract, including additional requirements, if any, specified in the SCC, and in any subsequent instructions ordered by the purchaser.

10. Delivery and documents

- 10.1 Delivery of the goods shall be made by the supplier in accordance with the terms specified in the contract. The details of shipping and / or other documents to be furnished by the supplier are specified in the SCC;
- 10.2 Documents to be submitted by the supplier are specified in the SCC.

11. Insurance

11.1 The goods supplied under the contract shall be fully insured in a freely convertible currency against loss or damage incidental to manufacture or acquisition, transportation, storage and delivery in the manner specified in the SCC

12. Transportation

12.1 Should a price other than an all-inclusive delivered price be required, this shall be specified in the SCC

13. Incidental Services

- 13.1 The supplier may be required to provide any or all of the following services, including additional services, if any, specified in the SCC:
 - (a) performance or supervision of on-site assembly and/or commissioning of the supplied goods;
 - (b) furnishing of tools required for assembly and/or maintenance of the supplied goods;
 - (c) furnishing of a detailed operations and maintenance manual for each appropriate unit of the supplied goods;
 - (d) performance or supervision or maintenance and/or repair of the supplied goods, for a period of time agreed by the parties, provided that this service shall not relieve the supplier of any warranty obligations under this contract; and
 - (e) training of the purchaser's personnel, at the supplier's plant and/or on-site, in assembly, start-up, operation, maintenance, and/or repair of the supplied goods.
- 13.2 Prices charged by the supplier for incidental services, if not included in the contract price for the goods, shall be agreed upon in advance by the parties and shall not exceed the prevailing rates charged to other parties by the supplier for similar services.

14. Spare Parts

- 14.1 As specified in the SCC, the supplier may be required to provide any or all of the following materials, notifications, and information pertaining to spare parts manufactured or distributed by the supplier:
 - (a) such spare parts as the purchaser may elect to purchase from the supplier, provided that this election shall not relieve the supplier of any warranty obligations under the contract; and
 - (b) in the event of termination of production of the spare parts:
 - (i) Advance notification to the purchaser of the pending termination, in sufficient time to permit the purchaser to procure needed requirements; and
 - (ii) following such termination, furnishing at no cost to the purchaser, the blueprints, drawings, and specifications of the spare parts, if requested.

15. Warranty

- 15.1 The supplier warrants the goods supplied under the contract are new, unused, of the most recent or current models, and that they incorporate all recent improvements in design and materials unless provided otherwise in the contract. The supplier further warrants that all goods supplied under this contract shall have no defect, arising from design, materials, or workmanship (except when the design and/or material is required by the purchaser's specifications) or from any act or omission of the supplier, that may develop under normal use of the supplied goods in the conditions prevailing in the country of final destination;
- 15.2 This warranty shall remain valid for twelve (12) months after the goods, or any portion thereof as the case may be, have been delivered to and accepted at the final destination indicated in the contract, or for eighteen (18) months after the date of shipment from the port or place of loading in the source country, whichever period concludes earlier, unless specified otherwise in SCC;
- 15.3 The purchaser shall promptly notify the supplier in writing of any claims arising under this warranty;
- 15.4 Upon receipt of such notice, the supplier shall within the period specified in the SCC and with all reasonable speed, repair or replace the defective goods or parts thereof, without costs to the purchaser;
- 15.5 If the supplier, having been notified, fails to remedy the defect(s) within the period specified in the SCC, the purchaser may proceed to take such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights which the purchaser may have against the supplier under the contract.

16. Payment

- 16.1 The method and conditions of payment to be made to the supplier under this contract shall be specified in SCC;
- 16.2 The supplier shall furnish the purchaser with an invoice accompanied by a copy of the delivery note and upon fulfilment of other obligations stipulated in the contract;
- 16.3 Payment shall be made promptly by the purchaser, but in no case later than thirty (30) days after submission of an invoice or claim by the supplier;
- 16.4 Payment will be made in Rand unless otherwise stipulated in the SCC;

17. Prices

17.1 Prices charged by the supplier for goods delivered and services performed under the contract shall not vary from prices quoted by the supplier in his bid, with the exception of any price adjustments authorised in the SCC or in the purchaser's request for bid validity extension, as the case may be;

18. Contract amendments

18.1 No variation in or modification of the terms of the contract shall be made except by written amendment signed by the parties concerned.

19. Assignment

19.1 The supplier shall not assign, in whole or in part, its obligations to perform under the contract, except with the purchaser's prior written consent.

20. Subcontracts

20.1 The supplier shall notify the purchaser in writing of all subcontracts awarded under this contract if not already specified in the bid. Such notification, in the original bid or later, shall not relieve the supplier from any liability or obligation under the contract.

21. Delays in the supplier's performance

- 21.1 Delivery of the goods and performance of services shall be made by the supplier in accordance with the time schedule prescribed by the purchaser in the contract.
- 21.2 If at any time during performance of the contract, the supplier or its subcontractor(s) should encounter conditions impeding timely delivery of the goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fact of the delay, its likely duration and its cause(s). As soon as practicable after receipt of the supplier's notice, the purchaser shall evaluate the situation and may at his discretion extend the supplier's time for performance, with or without the imposition of penalties, in which case the extension shall be ratified by the parties by amendment of contract;
- 21.3 No provision in a contract shall be deemed to prohibit the obtaining of supplies or services from a Government body or parastatal;
- 21.4 The right is reserved to procure outside of the contract small quantities or to have minor essential services executed if an emergency arises, if the supplier's point of supply is not situated at or near the place where the supplies are required, or the supplier's services are not readily available;
- 21.5 Except as provided under GG Clause 25, a delay by the supplier in the performance of its delivery obligations shall render the supplier liable to the imposition of penalties, pursuant to GCC Clause 22, unless an extension of time is agreed upon pursuant to GCC Clause 21.2 without the application of penalties;
- 21.6 Upon any delay beyond the delivery in the case of a supplies contract, the purchaser shall, without cancelling the contract, be entitled to purchase supplies of a similar quantity and up to the same quantity in substitution of the goods not supplied in conformity with the contract and to return any goods delivered later at the supplier's expense and risk, or to cancel the contract and buy such goods as may be required to complete the contract and without prejudice to his other rights, be entitled to claim damages from the supplier.

22. Penalties

22.1 Subject to GCC Clause 25, if the supplier fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance. The purchaser may also consider termination of the contract pursuant to GCC Clause 23.

23. Termination for default

- 23.1 The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, may terminate this contract in whole or in part:
 - (a) if the supplier fails to deliver any or all of the goods within the period(s) specified in the contract, or within any extension thereof granted by the purchaser pursuant to GCC Clause 21.2;
 - (b) if the supplier fails to perform any other obligation(s) under the contract; or
 - (c) if the supplier, in the judgement of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract.
- 23.2 In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner as its deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the supplier shall continue performance of the contract to the extent not terminated.

24. Anti-dumping and countervailing duties and rights

24.1 When, after date of bid, provisional payments are required, or anti-dumping or countervailing duties are imposed, or the amount of a provisional payment or anti-dumping or countervailing right is increased in respect of any dumped or subsidised import, NWPB is not liable for any amount so required or imposed, or for the amount of any such increase. When, after said date, such a provisional payment is no longer required or any such anti-dumping or countervailing right is abolished, or where the amount of such provisional payment or any such right is reduced, any such favourable difference shall on demand be paid forthwith by the contractor to NWPB or the NWPB may deduct such amounts from moneys (if any) which may otherwise be due to the contractor in regard to supplies or services which he delivered or rendered or is to deliver or render in terms of the contract or any other contract or another amount which may be due to him.

25. Force Majeure

- 25.1Notwithstanding the provisions of GCC Clauses 22 and 23, the supplier shall not be liable for forfeiture of its performance security, damages, or termination for default if and to the extent that his delay in performance or other failure to perform his obligations under the contract is the result of an event of force majeure;
- 25.2 If a force majeure situation arises, the supplier shall promptly notify the purchaser in writing of such condition and the cause thereof. Unless otherwise directed by the purchaser in writing, the supplier shall continue to perform its obligations under the contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the force majeure event;

26. Termination for insolvency

26.1 The purchaser may at any time terminate the contract by giving written notice to the supplier if the supplier becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the supplier, provided that such termination will not prejudice or affect any right of action or remedy which has accrued or will accrue thereafter to the purchaser.

27. Settlement of disputes

- 27.1 If any dispute or difference of any kind whatsoever arises between the purchaser and the supplier in connection with or arising out of the contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation;
- 27.2 If, after thirty (30) days, the parties have failed to resolve their dispute or difference by such mutual consultation, then either the purchaser or the supplier may give notice to the other party of his intention to commence with mediation. No mediation in respect of this matter may be commenced unless such notice is given to the other party;

- 27.3 Should it not be possible to settle a dispute by means of mediation, it may be settled in a South African court of law;
- 27.4 Mediation proceedings shall be conducted in accordance with the rules of procedure specified in SCC;
- 27.5 Notwithstanding any reference to mediation and/or court proceedings herein,
 - (a) the parties shall continue to perform their respective obligations under the contract unless they otherwise agree; and
 - (b) the purchaser shall pay the supplier any monies due to the supplier

28. Limitation of liability

- 28.1 Except in cases of criminal negligence or wilful misconduct, and in the case of infringement pursuant to Clause 6;
 - (a) the supplier shall not be liable to the purchaser, whether in contract, tort, or otherwise, for any indirect or consequential loss or damage, loss of use, loss of production, or loss of profits or interest costs, provided that this exclusion shall not apply to any obligation of the supplier to pay penalties and/or damages to the purchaser, and
 - (b) the aggregate liability of the supplier to the purchaser, whether under the contract, in tort or otherwise, shall not exceed the total contract price, provided that this limitation shall not apply
 - (c) to the cost of repairing or replacing defective equipment.

29. Governing Language

29.1 The contract shall be written in English. All correspondence and other documents pertaining to the contract that is exchanged by the parties shall also be written in English.

30. Applicable Law

30.1 The contract shall be interpreted in accordance with South African laws, unless otherwise specified in SCC.

31. Notices

- 31.1 Every written acceptance of a bid shall be posted to the supplier concerned by registered or certified mail and any other notice to him shall be posted by ordinary mail to the address furnished in his bid or to the address notified later by him in writing and such posting shall be deemed to be proper service of such notice;
- 31.2 The time mentioned in the contract documents for performing any act after such aforesaid notice has been given, shall be reckoned from the date of posting of such notice

32. Taxes and Duties

- 32.1 A foreign supplier shall be entirely responsible for all taxes, stamp duties, licence fees, and other such levies imposed outside the purchaser's country;

A letter of good standing from the Compensation Commissioner to this effect must be produced to the Employer upon signature of the agreement.
- 2. The Mandatory undertakes to ensure that he and/or subcontractors and/or their respective employers will at all times comply with the following conditions:
 - (a) The Mandatory shall assume the responsibility in terms of Section 16.1 of the Occupational Health and Safety Act. The Mandatory shall not delegate any duty in terms of Section 16.2 of this Act without the prior written approval of the Employer. If the Mandatory obtains such approval and delegates any duty in terms of Section 16.2 a copy of such written delegation shall immediately be forwarded to the Employer.
 - (b) All incidents referred to in the Occupational Health and Safety Act shall be reported by the Mandatory to the Department of Labour as well as to the Employer. The Employer will further be provided with copies of all written documentation relating to any incident.
 - (c) The Employer hereby obtains an interest in the issue of any formal enquiry conducted in terms of section 32 of the Occupational Health and Safety Act into any incident involving the Mandatory and/or his employees and/or his subcontractors.

PARK RULES AND REGULATIONS

NORTH WEST PARKS BOARD

1. RULES AND REGULATIONS FOR CONTRACTORS

Contractors shall at all times adhere to the provisions and regulations of the North West Parks Board (NWPB). Contractors / Suppliers shall particularly bear in mind that it is strictly prohibited to:

- Drive anywhere else than on an authorized road;
- Play loud music anywhere in the game reserve that may disturb other visitors;
- Exceed the indicated speed limit of 40 km/h;
- Injure, feed or disturb any form of wildlife;
- Uproot, pick, cut or damage any plant or be in possession of any part of a plant which is indigenous to the Heritage House;
- Place any name, letter, figure, symbol, mark, or picture on any object;
- Discard any burning object in such a manner or place as to cause fire;
- Be in possession of any explosives or of any unsealed or loaded firearm;
- Bring any pets, whether domestic or otherwise, into the park;
- Discard any article or refuse otherwise than by placing it in a receptacle or place intended therefore;
- Drive or park a vehicle in such a manner as to cause disturbance or inconvenience to any other person;
- Cause any noise between 21:30 and 06:00 likely to disturb any other person;
- Advertise or offer any goods for sale;
- Collect any money from the public or give public entertainment for reward;
- Stay overnight in any rest camp without the knowledge of the supervisor;
- Travel in the park during times other than those laid down by the regulations;
- Stay overnight at any place other than in a rest camp or a place other than that designated by the Board;
- Drive a vehicle in the game reserve without a valid driver's license.
- Offenders will be liable to a fine of up to R800,00.
- Entrance gates will be closed daily between 21:00 and 06:00

2. FEATURES REQUIRING SPECIAL ATTENTION

2.1 EXISTING SERVICES (CARE, DAMAGE AND PROTECTION)

Before commencing any excavation the contractor shall check the location of all existing pipes, lines, cables (underground and overhead), ducts, etc., within the area of the works with the NWPB Technical Officer and any other authorities concerned, in order to ensure that no damage is caused by construction operations. Any damage caused to existing services shall be repaired at the contractor's cost.

2.2 WORK WITHIN THE PARK

The contractor / supplier shall be responsible to ensure that all his employees obey the rules of the NWPB and follow any instructions given by officers of the NWPB concerning the environment.

A copy of these rules is enclosed and copies are also available at Heritage House Administration Offices.

2.3 PRESERVATION OF TREES, SHRUBS AND OTHER VEGETATION

The contractor shall take all necessary precautions to prevent the outbreak and spreading of bush fires and ensure that all his employees are aware of these precautions. No tree, bush or shrub may be damaged or removed without the permission of the Park Warden. Such permission will not be unreasonably withheld.

The contractor will be fined R500, 00 for each tree which is willfully destroyed or cut down without prior written permission of the Park Warden or consultant.

2.4 PREVENTION OF EROSION

All earthworks, berms, channels, spoil and borrow areas are to be constructed in such a way as to minimize the possibility of erosion. Any instructions received from the Park Official in this regard shall be strictly adhered to.

2.5 TRAFFIC AND DUST CONTROL

The contractor / supplier shall organize his activities in such a way as to cause the minimum disruption to the normal functioning of the park. A speed limit of 40 km/h is enforced throughout the game reserve to reduce dust and minimize disruption to wildlife. The contractor shall ensure that his employees abide by this restriction.

The penalty for exceeding the speed limit is R500,00.

2.6 PREVENTION OF ACCESS TO THE WORKS BY THE PUBLIC

The contractor shall ensure that the new works are clearly marked at all times to prevent access to the works by the public during construction. Access is to be prevented by placing drums and suitable barriers across all access roads to the works over weekends, public holidays and every evening at 18:00.

2.7 LIMITATION OF WORKING DAYS AND HOURS

No suppliers/ services shall be executed in the game reserve on Saturdays, Sundays and public holidays due to the influx of tourists. The contractor must ensure that all members of his personnel leave the game reserve before 18:00.

2.8 **PREVENTION OF DISEASES**

All on-site toilets are to be of the chemical type, and the toilet contents shall be disposed of regularly by the contractor to a designated area indicated by a Parks Official. Failure to comply will incur a penalty of R100,00 per incident.

The contractor shall provide, at each location, a suitable receptacle to contain all the daily refuse. The refuse shall be disposed of regularly by the contractor to a designated area indicated by a Parks Board Official.

Failure to comply will incur a penalty of R100,00 per incident.

2.9 PROTECTION OF WATER RESOURCES

The contractor / supplier shall, at all times, ensure that all equipment used to obtain water from any site in the game reserve is in good working order so as not to leak diesel, fuel or any foreign substances into the reserve's water resources. Failure to comply will incur a penalty of R500,00 per incident.

2.10 PERSONNEL

No site personnel shall wander away from the site location. A competent supervisor shall be on site at all times to ensure that the site personnel adhere to all regulations laid down by the NWPB.

2.11 RECLAMATION

All building rubble shall be removed from the game reserve and the site shall be reclaimed in accordance with NWPB specifications. (See attached copy). All short cuts through the game reserve caused by contractors' / suppliers' vehicles and personnel shall be reclaimed to NWPB specifications.

All burrow pits shall be reclaimed to NWPB specifications.

The penalty for failure to comply is R500,00 per site.

2.12 TRANSPORTATION

All LDVs shall be fitted with canopies or steel cages so as to enable the contractor /supplier to safely transport personnel to and from the work site in the game reserve.

2.13 OCCUPATIONAL HEALTH AND SAFETY ACT (ACT NO 85 OF 1993)

It is a prerequisite that all contractors working in NWP&TB Parks conform to the Health and Safety Agreement between the employer and the contractor (in terms of section 37(2) of the Occupational Health and Safety Act (Act No 85 of 1993).

Failure to comply with this Act will incur a penalty of no less than R1 000,00.

2.14 INDEMNITY PERMIT

All contractors / suppliers and their personnel shall sign a contractor's indemnity form before any work is carried out in the game reserve. Failure to comply will incur a penalty of R200,00 per incident.

2.15 ENVIRONMENTAL IMPACT REPORT

Where construction work is subject to the conditions laid down in the Scoping Report and other relevant correspondence from the Department of Environmental Affairs and Tourism the contractor shall ensure that all the mitigation measures for environmental impacts are applied as detailed in such reports.

2.16 Identification of Personnel & Vehicles

The contractor's vehicles must clearly display the name of the company on both sides of the vehicles in such a manner that it is visible to passing traffic.

All contractor employees must wear a uniform type of clothing displaying the company name on the front or back.

3. <u>RECLAMATION SPECIFICATIONS</u>

- 3.1 All building rubble shall be removed.
- 3.2 Ground shall be lightly ripped.
- 3.3 Grass with seed heads shall be placed on ripped ground or seeding as specified by the Parks Ecologist and sown into ripped ground.
- 3.4 Light brush cover shall be placed over the area.
- 3.5 Slope to be 1:1,5 on all sides of the reclamation area.
- 3.6 All reclamation shall be approved by the Park Manager.

The penalty for non-compliance with reclamation specifications is R500, 00 per area

SPECIAL CONDITIONS OF CONTRACT

1. Contract Period and hours of work:

- 1.1The period for the contract is one (1) year (twelve months) from the date of issue of the contract
- 1.2 Security officers on day duty will be on duty at 05h45 every day and go off duty once relieved at 18h00.
- 1.3 Security officers on night duty will be on duty at 17h45 every evening and go off at 06h00 once relieved.

2. Punctuality and Dress code:

- 2.1 All guards shall wear uniform and accessories that are appropriate for their work setting at all times. (Company approved Uniform)
- 2.2 It is the responsibility of the service provider to monitor their subordinate's compliance with this document.
- 2.3 Members should ensure that their uniform does not create destruction or cause a safety hazard.
- 2.4PSIRA ID cards must be carried by the guards at all times.
- 2.5 Day shift guards will be on duty from 06h00 to 18h00.
- 2.6 Night shift guards will be on duty from 18h00 to 06h00.
- 2.7 All guards must report 15 minutes early in order to do a proper hand over from the previous shift.
- 2.8No shift will be left unattended.
- 2.9 Incorrect or incomplete uniforms must be reported to control immediately.
- 2.10. When a uniform is worn, the guard wearing it must conduct himself in a correct and proper manner.
- 2.111 All guards will wear neat and clean uniform at all times. Uniform will not have the appearance of visible patches where repairs are made.
- 2.11. Security guards will greet all visitors, guests and staff members of the Board courteously.

3. Security Office Equipment:

- 3.1 Equipment must be kept in good working condition at all times.
- 3.2 Abuse of equipment will be dealt with severely.
- 3.3The security guards will be placed at the main entrance gates which he/she operates and it will be his/her responsibility to keep the area clean and tidy at all times.

4. Access / egress control – office hours:

- 4.1 The guard on duty must be deployed at the main entrance gates to the North West Parks Board - Head Office as of 06h00
- 4.2 All visitors will be registered and cleared, upon which they will be directed to reception between 08h00 and 16h00
- 4.3The Security Guard on duty must carry him/herself with dignity and look like presentable and professional at all times.
- 4.4Guards are not allowed to have visitors during their shifts. Even if it is a family member or anyone who does not form part of his/her shift.

5. Access / egress control – after hours:

- 5.1 Gates must at all times be kept closed and be locked after NWPB working hours.
- 5.2 Eight (8) Armed Security Guards (Grade C or deployed within the heritage house premises and TIDC;
 - 5.2.1 Two (2) Armed Security Guards during the day at the gate and one (1) Armed Security Guard at Reception Area of the Heritage House Building.
 - The two security guards at the main gate will alternate on site patrols whilst on the outside surrounding of Heritage House Building.
 - 5.2.2 During the night shift, one (1) security guard will remain at the main entrance gate and two (2) will patrol around Heritage House Building
 - 5.2.3 Armed Response vehicle to be on site during night shift
 - 5.3 Two (2) Armed Security Guards (Grade C and above) deployed at TIDC area
 - 5.4 One (1) Armed Security Guard during the day and one (1) at the night
 - 5.5 Security Guards are expected to carry side-arms (pistols/revolvers) and minimum of two semi-automatic rifles calibre .223 and above.
 - 5.6 Service provider to supply scanner/detector at the reception area for the duration of their contract.

6. Key control:

- 6.1 The guards on duty will be in possession of the keys for main entrance gates at all times.
- 6.2 These keys must be handed over from one shift to the next.
- 6.3 Lost keys must be reported immediately and locks replaced by security company. Duplicates of keys must be handed to the Resource Security Manager.

7. Patrols:

- 7.1 Patrols must be carried out at night by the guards not at the gate on an ongoing basis.
- 7.2 Submission of reports (client log history) on a weekly basis and as and when required.
- 7.3 Armed response in the event of break-ins, poaching and/or life threatening situations.
- 7.4 Service Provider to install, implement and maintain clocking points system for on-site patrols by Security Guards.

8. Fire evacuation and control:

- 8.1 Guards must familiarize themselves with the firefighting equipment and procedures in the complex.
- 8.2 In the event of a fire, the Control room of Security must be informed immediately.
- 8.3Where possible and without risking their lives, the guards must try to prevent the fire spreading.
- 8.4On arrival of the fire brigade, the guard must concentrate on preventing unauthorised entry and ensure that the fire department can work unhindered.

8.5 Abuse of firefighting equipment will be dealt with severely.

9. Occurrence book:

9.1 The occurrence book is an official document and must be treated as such. All pages must be numbered.

- 9.2 All incidents, checks and observations must be entered in the occurrence book.
- 9.3 Hand-over and take-over procedures must be entered in the occurrence book

10. Searches:

- 10.1 Clients / guests must not be searched at all but vehicles must be checked.
- 10.2 Surprise searches prior to notice can be conducted on vehicles only. The guard must look for suspicious items and equipment
- 10.3 Visitors are not allowed to remove equipment from the North West Parks Board - Head Office
- 10.4 If a guard suspects a person of any illegal activity, such guard then has to call the Resource Security Manager and/or Security Resource Officers
- 10.5 All visitors/guest, including staff members are prohibited from collecting, catching or harvesting any of the fauna and flora existing within the entire Cooke's Lake Complex.

11. Identification:

11.1 Should a guard not be able to identify a staff member, they must be referred to reception for assistance during working hours.

12. Special instructions:

- 12.1 Any person entering / leaving the property must report to the security guard on duty and sign the visitor's book./visitors slip
- 12.2 All staff vehicles entering and leaving the premises will be searched.
- 12.2 No unauthorized persons must be allowed on the premises.
- 12.3 Staff members reporting to work after hours or on public holidays or weekends will have their particulars noted in the visitor's book.
